Possible Topics

- 11. How Robust are Measures and Empirical Models in Tax Accounting Research?
- 12. The Influence of Taxation on Income and Wealth Inequality
- 13. How Do Taxes Affect Economic Growth?
- 14. Taxation of Financial Transactions and Capital Market Effects
- 15. The "Turn-of-the-Year" Effect: Tax and Nontax Reasons
